



SCHUTZHUND 3 / FH CLUB APPLICATION FORM



1. All eligible applicants must be Schutzhund Australia Inc. members.
2. Titles must be obtained under a Schutzhund Australia Inc. or *other Schutzhund Australia Inc. accepted Judges. (*See By-Laws for Trials.)
3. Trials must be hosted by a Schutzhund Australia Inc. or a recognized Schutzhund organization.
4. The titles, whether SchH1, SchH2, SchH3 or FH must be all earned by the same handler on a previously untitled dog.
5. All Schutzhund protection scores must adhere to Schutzhund Australia Inc. rulebook standard.
6. Applicants for the FH Club must have completed a BH title before the FH.
7. When requested, all titles must be confirmed by an attached copy of the trials entered into the dog's certified scorebook.
8. Applications for the SchH 3 Club and the FH Club can be made separately of each other.

After your accomplishments are verified, you will become part of the permanent list that is kept on record by Schutzhund Australia Inc. Administration and published on the Schutzhund Australia Inc. website, and you become eligible to acquire a red Schutzhund Australia "SchH3 Club" jacket, embroidered with the SchH 3 Club logo, &/or a "FH Club" badge from the Organisation.
